Article 1

Breeder is selling and Purchaser is buying "Siberian-Neva Masquerade" breed cat born with the name _____, pedigree number _____. Breeder guarantees the accuracy of the information specified in pedigree.

Article 2

Price of the kitten is _____ and Purchaser is obliged to pay full amount of the price at the moment of taking possession of the kitten reduced by the amount of the deposit Purchaser made on (date) _____ in the amount of _____. Upon received deposit Breeder is obliged to fulfil all agreed stipulations of this Agreement. If Breeder fails to fulfil his/her obligations, he/she is bound to return deposit to the Purchaser. In the case of Purchaser withdrawal from the purchase of the kitten after making deposit Breeder has no obligation to return deposit to the Purchaser.

All transportation costs of the kitten in its entirety are on Purchaser expense.

Article 3

Buyer agrees that after taking possession of the kitten from the Cattery will take good care of it paying full attention to its welfare, providing adequate and appropriate food and accommodation and enable provision of health prevention and any other required standard care.

Purchaser cannot sell or give away above mentioned kitten without Breeders consent.

In the case Purchaser ignore the above obligations and potentially jeopardize a healthy and normal life for a kitten, the Breeder has the right to take this kitten back to the cattery with no obligation to repay the Purchaser the compensation paid for the kitten.

Article 4

Kitten in this Agreement is sold for pet only, meaning it is not sold for breeding, as it is also stated in accompanying pedigree. According to the previously made arrangements, Breeder will give already neutered/spayed kitten to the Purchaser or if not, Purchaser will take responsibility for neutering/spaying kitten in certain interval. If such a case, Purchaser is obliged to comply with the agreed neutering/spaying deadline and after its completion, inform the Breeder about it.

If any suspicion arises that Purchaser did not comply with the above-mentioned condition, Breeder has the right to carry out all the necessary tests and DNA testing of potential parents and offspring to determine their origin. The Purchaser is required to enable Breeder to take DNA samples for testing. All costs of testing are covered by Breeder, unless violation of this Article of the Agreement is determined. If Purchaser fail to comply with the conditions of neutering/spaying obligations stipulated in this Agreement, Breeder is entitled, in order to meet the agreed conditions, to initiate dispute before the competent court.

Article 5

Breeder guarantee that the kitten in this Agreement is healthy and received all necessary vaccinations, as well as regular treatments for internal and external parasites, all of which is verified by assigned veterinarian in the kitten's Passport.

When giving the kitten to Purchaser, Breeder is obliged to issue all accompanied papers related to kitten such as pedigree, transfer list and registration slip from TICA.

Breeder is obliged to give to the Purchaser kitten that is orderly chipped and registered in the database.

Breeder guarantees that kitten doesn't have any symptoms of infectious diseases for the following 7 (seven) days starting from the moment of kitten's transfer into Purchaser possession.

Breeder guarantees that kitten is not carrier of PKD and HCM genetic disorders for the following 3 (three) years after its birth.

Article 6

If Purchaser use kitten for any commercial purposes, such as marketing, advertisements or any public commercial promotions, he/she is obliged to state the full original name of the kitten from the pedigree.

Article 7

If Purchaser violates any Article of this Agreement, in order to protect its rights, Breeder can exercise the right to bring the matter to the competent court. In case of any breach of this Agreement Purchaser is obliged to pay to the breeder the damage in the amount of 5,000.00 EUR.

Article 8

This Agreement is made in 2 (two) identical copies, one for Purchaser and the other for Breeder.

With their signatures both Breeder and Purchaser ratify all the terms stipulated in this Agreement.
